# **Draft Resolutions for the April 16, 2015 Town Board Meeting**

- 1. Accept Bank Of Greene County Loan Proposal: Whereas the Bank of Greene County has submitted a proposal to allow the Town to borrow up to \$400,000 for five years at 1.99%, with a 90 day rate guarantee, for the purpose of financing the Town's planned purchase of two Kenworth trucks with dump body, plow and wing, and whereas, this proposal was the most attractive of the proposals from the four banks which were contacted, therefore it is Resolved, that the Ancram Town Supervisor is authorized to accept the proposal from the Bank of Greene County, and is authorized execute documents necessary to secure a loan for not to exceed \$400,000 for five years at 1.99% to finance the purchase of two plow trucks.
- **2. Appoint Camp Director: Resolved**, that subject to approval by the County of Columbia, Samantha Mason is appointed Director of the Ancram Kid's Camp for 2015.
- 3. Accept Mowing & Pool bid: We have two options to consider, depending on whether there are any alternatives for the pool maintenance contract, and how reference checks on Herman's turn out. We should have more information on both matters by our meeting on 4/16.

**Option a: Whereas,** there was only one bid to provide pool maintenance services in 2015, and whereas that bid was contingent on also being awarded the 2015 lawn maintenance contract, and whereas there are no other suppliers of the pool maintenance services needed by the Town as outlined in the pool RFP, and whereas if the pool is not opened and maintained as in prior years the Ancram Kid's Camp will be disadvantaged, therefore it is Resolved, that the 2015 mowing and pool contracts be awarded to Boice Homecare as the only bidder who is able to meet the Town's needs for both lawn maintenance and pool maintenance as outlined in the lawn and pool maintenance specifications.

**Option b: Whereas,** Herman's Lawn Care provided the lowest bid in response to the 2015 Town lawn maintenance RFP, and whereas Herman's references have been checked and determined to be satisfactory, and **whereas** the Town has made arrangements with the XYZ Pool Maintenance Company to open, manage and maintain the town pool in 2015 according to the specifications in the pool maintenance RFP, **therefore it is Resolved** that Herman's Lawn Care be awarded the lawn maintenance contract, and XYZ Pool Maintenance Company be awarded the pool maintenance contract for 2015.

- **4. Appoint Attorney:** Resolved that the Town Supervisor is authorized to retain Mitchell Khosrova, attorney, to provide legal services to the Town of Ancram.
- **5. Approve revised Employee Handbook: Resolved,** that the Ancram Employee Handbook as revised be approved, subject to any minor final edits as proposed.
- **6. Adopt Unsafe Building Law: Resolved,** that the proposed Unsafe Building Law, Local Law #2 of 2015, is hereby adopted, and will become effective upon filing by the Town Clerk with the NYS Secretary of State.

- **7. Appoint Member to Board of Assessment Review: Resolved**, that Palmer Irving be appointed to the Board of Assessment Review to replace Larry Berg, for a term ending October 1, 2016.
- **8. Approve revised Charter Franchise Agreement: Resolved,** that the revised Charter Communications franchise agreement be approved for a term of 5 years.

### **FRANCHISE AGREEMENT**

WHEREAS, the Grantor finds that the Grantee has substantially complied with the material terms of the current Franchise under applicable laws, and that the financial, legal

and technical ability of the Grantee is sufficient to provide services, facilities and equipment necessary to meet the future cable-related needs of the community, and

WHEREAS, having afforded the public adequate notice and opportunity for comment, Grantor desires to enter into this Franchise with the Grantee for the construction and operation of a cable system on the terms set forth herein; and

WHEREAS, the Grantor and Grantee have complied with all federal and Statemandated procedural and substantive requirements pertinent to this franchise renewal;

WHEREAS, the Board, in granting this franchise renewal, embodied in the agreement the results of its review and negotiations with Charter Communications and has determined that said franchise agreement and Charter Communications respectively, fulfills and will fulfill the needs of the Town of Ancram, NY, with respect to cable television service and complies with the standards and requirements of the New York State Public Service Commission (NYSPSC);
