Nandor Sala and Ben Goldberg of American Solar Partners appeared on behalf of the applicants. They submitted additional documents showing that the proposed system would not provide 100% of the agricultural operations energy demand. The proposed location is sited behind an existing building; however, it will not be fully screened from all directions and angles. The system is comprised of 652 panels. The height of the panels will be 9 feet. The panels will not have tracking. Each row will be 16 feet wide. The panels have an expected lifespan of 25 years and the inverted is expected to last 20 years. The representatives stated that by that time secondary industries such as solar recycling companies will have sprung up, as has already occurred in Europe.

Dennis Sigler motioned to declare the Planning Board Lead agency for the purposes of environmental review. The motion was seconded by James Stickle. All in favor, motion carries.
